OVERVIEW

This professional course is designed to immerse participants in the field of career development under the expert guidance of senior researcher and practitioner Dr. Jim Bright and career education specialists, BECOME Education.

The course is hosted and administered by BECOME Education and provides a professional grounding in career counselling and careers education for adults and students.

The Career Counselling, Coaching and Assessment Course is for:

- People wanting to offer career counselling, coaching and assessment services to clients such as students in schools and higher education, sport or business clients.
- Those who need a solid basis in theory as well as practical techniques, tools and considerations for contemporary career development.
- Existing practitioners keen to develop new skills and refresh their knowledge.
- New and existing practitioners who want to be inspired by the latest evidence and best practice.

The course covers:

- How and when career decisions are made; the role of the careers professional and skills used in providing practical career development assistance.
- Ways to enhance individuals' self-efficacy and confidence in career exploration, including tools and techniques.
- An understanding of the effect of uncertainty and the changing nature of work on career planning for adults and school-age young people.
- Strategies that go beyond matching approaches to careers.
- Current research and effective practice as applied to schools, higher education and other clients in a careers context.

IN-PERSON INTENSIVE

The 3-day in-person intensive model includes 20 hours of in-person instruction from Dr. Jim Bright and BECOME Education. Morning tea and lunch are provided on each day. Optional evening networking may occur.

HYBRID LIVE ONLINE

Flexible hybrid delivery combining self-paced and live online learning. Participants will have 4 months to complete 17 hours of online self-paced learning plus 3 hours of live online interactive sessions with Dr. Jim Bright and BECOME. Course content remains engaging in audio, video and written formats.

You'll stay with a consistent cohort so that you develop your professional network. Join during October, January and May each year or at a date that suits you.



Fees

The 2025 fee for Career Counselling, Coaching and Assessment course is \$2150 (ex GST). The fee is the same for each of the two delivery formats. Discounts are available for bulk bookings. An optional additional fee applies if participants undertake the Assessment for proof of learning for RMIT credit, as outlined below. This fee is \$250 (ex GST).

Accreditation with RMIT University

This Career Coaching, Counselling and Assessment (CCCA) course is linked to the RMIT Graduate Certificate in Career Education and Development. Upon successful completion of the CCCA course and the agreed assessment tasks, students will be eligible for recognition of prior learning towards the foundation course Practices in Career Design (HWSS2240).

Eligibility for the RMIT Graduate Certificate in Career Education and Development is assessed through the standard RMIT admissions process and students planning to progress towards this Graduate Certificate should check their eligibility and apply directly through RMIT. In other words, doing the CCCA and its assessment tasks doesn't automatically make you eligible for the RMIT Graduate Certificate program but if you're eligible to enrol and you do enrol, successful completion of the CCCA and its assessment can count towards 25% of the RMIT program.

The optional assessment for credit comprises two tasks plus engagement in discussion during the hybrid live online or in-person CCCA. It attracts an administrative fee of \$250.

Course Terms and Conditions

- The participant agrees to pay the course fees, including GST, before commencement of the course. The participant accepts that payment in full is required even if they do not finish the course.
